IF YOUR APPLICATION IS ACCEPTED, THE FOLLOWING WILL APPLY:

**ART DELIVERY:** All arrangements for the delivery and pick up of artwork must be made by the artist or a representative of the artist (Artists' Committee members excluded). Artwork must be delivered to Ico Gallery on Saturday, September 25, 2010 between the hours of 10:00 and 11:00 am. **All work MUST be equipped for installation.** For hanging artwork, the gallery requires that works have a hanging wire. If special equipment is required, it must be provided by the artist, or the artist should discuss this with an Artists' Committee member well before the event. Film/video artists are welcome to submit pre-cued VHS tapes or DVDs and must provide their own playback equipment on the day of the exhibition. **All submissions must include the artist's name and title of the artwork.** Due to the short time-frame for installing the show, it is essential that all works be delivered on time. **NO DELIVERIES WILL BE ACCEPTED AFTER 11:00 AM ON SEPTEMBER 25<sup>TH</sup> WITHOUT PRIOR NOTICE!!!** After artists deliver their work, the Artists' Committee will personally handle all hanging and positioning. Exceptions will be made if special instructions for installation are required.

**ART PICK-UP:** On September 26<sup>th</sup>, all artwork must be removed by the artist between 5:00 pm and 6:00 pm. Artwork may also be picked up on Monday, September 27<sup>th</sup>, but only upon special request. The New York ASA cannot assume responsibility for damage incurred before or after the exhibition. Artwork will be handled with the greatest care, however the New York ASA assumes no liability for work while on the premises.

**SALES:** A 20% commission will be retained by the New York ASA for work sold during the exhibition. Art sales for anything other than submitted artwork are not allowed at anytime during the event. The Opening Reception is scheduled for Saturday night, September 25<sup>th</sup> and is free and open to the public.
